### Residual Bequest Language

*I give and devise to Plymouth Congregational Church of Lawrence, Kansas (Tax ID # 48-0548367), located in Lawrence, KS, all (or state a percentage) of the rest, residue, and remainder of my estate, both real and personal, to be used for its general support (or for the support of a specific fund or program).*

### Specific Bequest Language

Naming Plymouth as a beneficiary of a specific amount from your estate is easy:  
*I give and devise to Plymouth Congregational Church of Lawrence, Kansas (Tax ID # 48-0548367), located in Lawrence, KS, the sum of \$\_\_\_\_\_ (or asset) to be used for its general support (or for the support of a specific fund or program).*

### Contingent Bequest Language
